Dear Parents/Carers of St Clement's,

As a catholic school, St Clement's is voluntary aided which basically means that the school is responsible for 10% of all financial investment in the school buildings and grounds. Unfortunately, the upkeep and maintenance of our school never stops, which means that the governors will continue to raise funds.

Many parents of our school already make regular contributions to the fund and the Governing Body is asking whether it is possible for you to do the same. We suggest that each family makes a minimum contribution of £10 per month, however every contribution, no matter how small, will be gratefully received. Attached to this letter you will find a standing order mandate, so you can set up your regular contributions. Please complete it and return it to the school office or scan it and email it to info@stclements.surrey.sch.uk.

If you pay Income Tax, it is possible for you to "gift aid" your contribution. This means that we will be able to claim back the standard rate tax you have paid on your contributions. So, for example, if you contribute £10, we can claim back from the government an extra £2.50 - at no cost to you, but at great benefit to the school. To enable us to reclaim the tax on your contributions, please complete the attached Gift Aid Declaration and return it to the school office or email it instead.

We hope that you will be able to participate in the scheme to support our school and to enable the Governing Body to fulfil its role in keeping the school buildings and grounds a safe and enjoyable environment for your children to grow and learn.
